To allow your child to submit her testimonial and photograph you must complete the following form including your signature and date, and return it to us to the address listed at the bottom of the form. You must return the form in its entirety. Do not cut up or alter the form in anyway.

Any images submitted must be original photographs printed on photo quality paper. Make sure that you include your child’s testimonial essay, which should discuss what kind of volunteering or acts of charity she/he has done and why it is important to her/him. Your child’s testimonial should be printed, not hand written, to ensure that it is correctly displayed on karitokids.com.

Sending in all your information does not guarantee that your child will appear on karitokids.com. We reserve the right to choose the photo and testimonials we post. Submissions without a signed release form will not be considered. Materials you send will not be returned and become the property of KidsGive. Submissions that have been chosen may not appear on the site for several months.
